I. Introduction

- 1. By its decision BC-11/8, the eleventh meeting of the Conference of the Parties to the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal noted with concern that the national reporting targets for the year 2010 approved by the Conference of the Parties at its tenth meeting had not been met and acknowledged that the problem of non-reporting, incomplete reporting or late reporting was all the more serious because of the close link between the core obligations of the Convention and the obligation to submit national reports in accordance with paragraph 3 of Article 13 of the Convention.
- 2. In the same decision, the Conference of the Parties adopted the work programme for the biennium 2014–2015 of the Committee administering the mechanism for promoting implementation and compliance of the Basel Convention (hereinafter "the Committee"), attached to that decision. Within its mandate to review general issues of compliance and implementation under the Convention, the Committee was requested to undertake several activities with the objective of improving timely and complete national reporting under paragraph 3 of Article 13 of the Convention.
- 3. Among the activities listed in the 2014–2015 work programme is for the Committee to classify and publish parties' individual compliance performance with regard to the annual reporting obligations for 2011–2012, based on the criteria, categories and targets approved by the Conference of the Parties at its tenth meeting. A classification of parties' individual compliance performance with regard to the annual reporting obligations for preceding years, namely 2009 and 2010, was undertaken by the Committee as mandated by the tenth meeting of the Conference of the Parties in its decision BC-10/11.

- 4. The criteria and categories approved by the Conference of the Parties are set out in paragraph 26 of the report of the Committee to the tenth meeting of the Conference of the Parties1, namely two criteria (timeliness and completeness of the report) and five categories:
 - (a) Fully reported and on time;
 - (b) Fully reported (but late);
 - (c) Reporting incomplete (but on time);
 - (d) Reporting incomplete (and late);
 - (e) Not reported.
- 5. The national reporting targets adopted by the Conference of the Parties in its decision BC-11/8 as a way of measuring progress in the overall implementation of and compliance with paragraph 3 of Article 13 of the Convention are:
- (a) Thirty per cent of reports due for 2011 and subsequent years are submitted on time (baseline: 13.3 per cent for the reports due for 2006);
- (b) Twenty per cent of reports due for 2011 and 2012 and subsequent years are submitted complete (baseline: 9 per cent for the reports due for 2006).

II. Implementation

- 6. The classification of parties' compliance performance with regard to the annual reporting obligations for 2011 and 2012 was undertaken by the Committee based on the criteria, categories and targets approved by the Conference of the Parties at its tenth meeting. The classification for 2011 was considered by the Committee during its tenth meeting (Paris, 5 and 6 December 2013, and 8 May 2014),² while the classification for 2012 was considered by the Committee during its eleventh meeting (Geneva, 22 to 24 September 2014).³
- 7. As agreed by the Committee during its eleventh meeting, the classification of parties' compliance performance with regard to the annual reporting obligation for 2011 and 2012 was published on the Convention's website along with an explanatory note⁴ and made available to parties through a 13 October 2014 communication with an invitation to comment by 15 November 2014. Updated classifications based on the comments received⁵ were subsequently prepared, as set out in annex I and II to the present note.
- 8. The information provided in the classifications includes, for each year:
- (a) A classification of parties' compliance performance with respect to the annual reporting obligation based on regional grouping;
- (b) A classification of parties' compliance performance with respect to the annual reporting obligation based on regional grouping with information on the completeness of Parts I and II of the questionnaire;
 - (c) An overview of reporting rates and timeliness of reporting based on regional grouping;
- (d) A classification of parties' compliance performance with respect to the annual reporting obligation with a breakdown on a party basis;
- (e) An overview of completeness of answers to each question and sub-question of the national report.
- 9. As mandated by the Conference of the Parties and under the guidance of the Committee, the Secretariat undertook the classification on the basis of the following assumptions:
- (a) The information was used as reported by parties, without prejudice to the Secretariat's quality control;

- (b) The completeness of national reports is reviewed on the basis of the answers provided by parties to all questions and sub-questions of the revised questionnaire on transmission of information (in accordance with Articles 13 and 16 of the Convention), with the exception of table 8B that is not mandatory;⁶
- (c) Should a report contain answers that do not provide the information sought (such as "estimated data", "in preparation", "no data available" or "no information"), the party will not be considered to have fully reported. ⁷
- 10. The Secretariat undertook the classification exercise using in-house resources. The following elements should be borne in mind:
- (a) The Secretariat had to carry out the classification exercise manually by looking at the responses provided by each party to each question, sub-question and individual elements of each table of the reporting questionnaire. This is mainly because of two reasons: the current national reporting database of the Secretariat does not offer the possibility of queries related to the criteria adopted by the Conference of the Parties ("complete/incomplete", "on time/late"); and given the current format of the questionnaire, whether a response is "complete" may require that its content be understood;
- (b) In some instances, the Secretariat double-checked answers provided in reports for previous years to determine whether an answer to a specific question could be considered "complete". This is because parties usually use a pre-filled questionnaire where they indicate which responses have been updated since the last time they have reported. It does happen that the latest report specifies that a response was "not updated", while at the same time no answer is given to the question. In that case, the information reported for a previous year was taken into account and the response considered "complete";
- (c) The Secretariat reviewed 165 reports (85 for 2011 and 80 for 2012) but did not have the capacity to undertake a second full review to cross-check all the classification items individually (for e.g., with respect to the classification of individual parties' compliance performance);
- (d) The Secretariat did not review the content of individual responses, except when this was needed to implement the assumptions mentioned above. For instance, if a party responded to question 2 (c) that it has a national definition of hazardous wastes under article 1.1 (b), then the Secretariat has considered answers to table 8A on the amount of generation of hazardous wastes and other wastes as "complete" only when information on the three values sought (article 1.1 (a) wastes, article 1.1 (b) wastes and other wastes) was provided;
- (e) The Secretariat has considered that answers to some questions/tables were "complete" when a party stated that the sought information could be found on a specific website or with the Focal Point of the Convention. But the Secretariat did not double-check if the sought content was really available on the specified website;
- (f) The Secretariat classified parties, per region/group, according to the UNEP classification set by the UNEP-GRID.
- 11. As referred to in the note by the Secretariat on the Committee for Administering the Mechanism for Promoting Implementation and Compliance of the Basel Convention (UNEP/CHW.12/9), the annexes to the present note set out updated classifications of parties' individual compliance performance with regard to their annual national reporting obligations for 2011 and 2012. The present note, including its annexes, has not been formally edited.

On the other hand, in cases where the questionnaire seeks specific information such as data on imports or generated wastes, the answer "in preparation" was not considered as a complete answer as this answer does not provide the information sought.
